JOB DESCRIPTION: Afternoons shift work to deliver health care service to the inmate population of the St. Charles County Correctional Facility within the scope of licensing abilities. Reviews health screening of detention facility residents. Interviews persons regarding health history and current status. Makes a physical assessment of prisoners with medical complaints, prepares for physical exams and refers sick or injured persons to appropriate health care professional. Assesses individuals requiring mental health intervention. Documents health care given, prepares and maintains health records and monitors health care given to detention facility residents including treatment and medication. Monitors and maintains health care supplies and equipment. Conducts random inspections of inmate units for sanitary conditions and files reports of findings. Performs other duties as assigned by Health Services Coordinator.

REQUIREMENTS: Must be licensed as a Licensed Practical Nurse or Registered Nurse in the State of Missouri. Requires completion of an appropriate accredited medical program. Requires two years of professional experience preferably in an emergency department or correctional setting. An equivalent combination of education, training and experience will be considered. Must be free from felony conviction. Knowledge of medical examination and diagnosis techniques and procedures. Knowledge of medications and their effects. Ability to conduct routine assessments. Ability to interpret medical data. Ability to prepare medical reports. Ability to interface with government officials, medical personnel, corrections facility personnel and prisoners. Strong written and verbal communication skills required.

SCHEDULE: **Primarily 3pm – 11pm shift coverage. Prefer commitment to work 2-3 shifts per week, which would include 1 weekend per month.**
